_____ 1) a) I understand that my child will not be enrolled until the Re-enrollment forms on RenWeb or Online Application are completed in their entirety. b) The non-refundable/non-transferable registration fee has been paid. c) This form has been filled out and signed and d) The Financial Contract is hand delivered to Mrs. Mickie Lewis in the Business Office by a Financially Responsible Party for a brief meeting. *** Enrollment is pending a confirmation email. This email will guarantee your student's spot. **I further understand that once my child is enrolled, I must notify the Business Office in writing if my child will not attend Berean for the 2017/2018 school year. I understand that I will be responsible for the 1st month of tuition and any schools fees that have been posted to my account if I withdraw on or after the 1st day of school and a \$50 withdrawal fee will be applied to my account.**

I UNDERSTAND BEREAN DOES NOT ACCEPT CREDIT CARDS OR ONLINE PAYMENTS.

_____ 2) There will be NO REFUNDS for partial months. If a student attends one day in any given month, you will be charged for the full month. A late fee will be assessed after the 1st of each month. **Late fees are billed per student not by family.** Billing is on a monthly installment plan for K5-12th grades. **All payments are due the 1st day of the month.** I understand that ALL the school fees that apply to my account are non-refundable and non-transferable once they have been billed. These fees as well as discounts for early payments can be found on the Financial Information Sheet on page two of this document.

_____ 3) Report cards will be held and access to RenWeb denied if the account becomes outstanding during any grading period until the account has been paid in full. If a check is returned to Berean for any reason, it must be replaced with cash, cashier's check or money order within five days of notification along with the return check fee. Academic records will not be released to any person or institution until the account is paid in full.

_____ 4) **AT THE POINT AN ACCOUNT BECOMES 30 DAYS IN ARREARS; YOUR STUDENT CAN NOT ATTEND CLASS UNTIL THE ACCOUNT IS CURRENT. THE ACCOUNT MUST BE PAID IN FULL IN ORDER FOR THE STUDENT TO RETURN TO CLASS.**

_____ 5) Parents are responsible for obtaining all Handbooks, Registration Forms, Financial Information Forms and Policy Sheets for all billable items. This includes but is not limited to athletics, aftercare, and food services. Berean will make every effort to disburse this material, but it remains the parents' responsibility to acquire these documents. Berean will provide access to these documents via RenWeb, website and/or School Lobby.

_____ 6) The undersigned hereby promises to pay all costs of collection for any delinquent accounts involving their child, including reasonable attorney's fees, whether suit be brought or not and whether such costs of collection are normally allowed as court costs or not.

_____ 7) If, at any time, I feel it necessary as a school parent to pursue legal action against Berean Christian School in a court of law, and if a judgment is handed down in the favor of Berean Christian School, I agree to pay, in full, all legal and attorney fees, court costs, and all other expenses that the school may incur as a result of my action.

- K5-4th Grade \$9,250.00
- 5th-6th Grade \$9,625.00

- 12th Grade \$10,450.00

(The 12th grade tuition rate includes the fee for the dual enrollment LDR 150 Life Calling Class)

ESE Services:

Students that qualify for the McKay Scholarship will pay the grade appropriate tuition rate. The McKay Scholarship will cover the ESE services (K5-12th Grade). See ESE Fee Schedule.
